1	Our advisers commented favourably on the capacity building approach to develop action plans and follow up on these, working closely with the municipality, as well as the strong knowledge sharing and dissemination element.	PPIAF to communicate this to the TTL
2	For Ethiopia we note the plan is to do a credit-worthiness academy in March next year, but that Ethiopia is not on the list for further TA. This could fit nicely with a new programme DFID is designing here as at the end of the 5 days participants will have a draft plan of action of specific reforms, capacity building etc. required. If this goes well it could create demand for our new investment facility and DFID could potentially pick up any further TA requests that flow from it.	PPIAF has communicated this to the TTL. In advance of the Ethiopia Academy, the TTL will invite the DFID country team to participate in a partners' conference call to communicate and coordinate effort.
3	On linking with other WB Urban work: In the PCN at the end it talks about the WB ensuring links and consultation with other stakeholders as needed. 4	City Size: Are you looking at cities of any size? The 5 cities listed in the diagram on page 6 of the PCN that are receiving on-going TA are capital or primate cities. We know that future growth in cities is going to come from secondary cities in particular – any chance there can be a specific push to look at these cities as well – we know that since this is about credit worthiness the primate cities are going to be usually in the best position to succeed in this area, but thinking about how to tailor this type of training and TA to smaller cities could be useful.	The inclusion of secondary cities is a priority for the Initiative, precisely for the reasons raised by the donor representative. As a result, in Tanzania the TA already targets 34 municipalities. In Colombia the TA is being finalized for 17 municipalities. In Rwanda and Uganda, the Academy- expects a total of 60 local governments to participate. The self-assessment and action-planning tools, allow easy customization of interventions to cities of different sizes.
5	Focus on FCAS: Again not so easy to work with fragile cities but often they lack a private sector so attracting investment from outside is important. Can we suggest PPIAF look at how to deliver this type of initiative in a fragile city?	PPIAF will emphasize the focus on FCAS under the Initiative and at the portfolio level, to generate lessons on how to deliver this type of initiative in a fragile city. An Academy is already planned for West Bank and Gaza at the end of May, 2015. The Initiative expects to learn from this Academy, as it pilots and adjusts its approach to the context, both at the Academy and post-Academy stages.
